Accordingly, as an Organization, we resolve to support only organizations and individuals that are based within the United States of America. The Circle, therefore, shall not send money or resources of any kind to foreign organizations or individuals.

Further, The Circle's activities must ever and always be in accord with the principles and practices laid down by Avatar Meher Baba. As taught by Baba in his statement "How to Love God", The Circle shall only support organizations and individuals that strive to "...love our fellow human beings..." and that do their work consistent with the understanding that "...the greatest act of devotion and worship to God is not to hurt or harm any of His beings..."
