SUMMARY HIGHLIGHTS:

A Quorum existing, the Annual Meeting proceeded to business. A motion to accept the 2016 Annual Meeting Minutes was made by Don McBride; seconded by Laura Crabtree and PASSED UNANIMOUSLY.

Treasurer Jeff Stearns reported that The Circle began the Year with a bank balance of \$8400.00, and as of the Meeting Date (12/09/2017), it was \$15,700.00

Dennis Wolterding gave The President's Report which was accepted by acclamation of the Members.

Steve Koren, Director of Fundraising, gave a "Doors to the Future" presentation and a fundraising appeal.

Jerry Edwards and Avatar Blue provided interlude music while the ballots were being counted.

The Election was duly held in accordance with the By-Laws. The Proxy/Ballot and Instructions used are attached. (Note: Christina Riley resigned as Director at Large 1 and John Leiter replaced her on the Board too late for the Ballots to be revised. Members revised their Ballots at the Election and voted accordingly.)

UP ON SANGUINE AIR ANNUAL ADDRESS TO THE MEMBERSHIP 2017 Dennis Jan Wolterding, President

CIRCLE PROXY/BALLOT INSTRUCTIONS—2017 ANNUAL MEETING

VOTING FOR THE DIRECTORS

Enclosed please find the Proxy/Ballot for the 2017 Annual Meeting of Avatar Meher Baba's Circle of Friends, Inc. (The Circle). Five (5) directorships, all currently filled by incumbents, are up for election. The term of each director is two years.

You may cast a "Yes" vote or a "No" vote for each directorship by making an "x" or checkmark in the space to the right of the name. Or you may cast a vote for another nominee who is proposed and seconded on the floor of the Annual Meeting (on the line that begins with OR). For such a nominee, simply write in their name on the appropriate line under the directorship for which they are nominated. At the Annual Meeting, you have the right to nominate (subject to a second) any Circle member in good standing for the five directorships up for election, subject to the By-Law condition governing President and Vice-President. Before nominating anyone for any directorship, however, we urge you to ensure that the individual is ready and willing to serve on the Circle Board. You may also choose to "abstain" from voting for one or more directors by marking the appropriate space in the column entitled "Abstain".

PROXY AGENT

Kindly note that this Proxy/Ballot designates Mr. Jeff Stearns as the Proxy Agent. Mr. Stearns will ensure that, in your absence, your ballot is properly submitted and counted. Moreover, unless you specifically choose to abstain by marking your ballot in the area provided, Mr. Stearns shall have the right to cast your vote for any directorships that you leave unmarked.

You MUST sign and date your ballot for it to be counted. We also ask that you print your name in the space provided.

Even if you choose to abstain from voting for anything, please know that your proxy/ballot counts in determining a quorum for the Annual Meeting so we urge you to return it to us.
